To secure emissions compliance, your Alfa Laval PureSOx system needs accurate measurements from its PAH and turbidity sensors*. These sensors must be factory calibrated every two years, which can be handled simply and conveniently through our Exchange Programme.

What we do

Alfa Laval guarantees that your PureSOx system always has functional and accurate PAH and turbidity sensors, so that you can prove your compliance and avoid fines. When the sensors require factory service after two years, we swap them out with replacements calibrated to MEPC specifications.

The Exchange Programme includes a full warranty. If a properly maintained sensor fails before regular service is required, we will send you a serviceable one free of charge.

Scope of service

The Exchange Programme for PureSOx includes the following during a six-year period*:

- Guaranteed on-time replacements We provide replacement PAH and turbidity sensors every two years, in time for your existing sensors' required calibration. The replacement sensors have been factory inspected, maintained, cleaned and calibrated.
- Full warranty

After a sensor exchange the warranty of the sensors is extended by 24 months.

Complete replacement logistics

Alfa Laval acts as your partner, managing all scheduling and replacement logistics. Replacement sensors are available in any major port within three days.
